

### **Background**

In criminal justice, prisoners are isolated, far-from-society, entity outside of the concern of most people. However, prisoners do not exist in a vacuum, rather surrounded by families who have to deal with the criminal nature of a family member, the absence of said individual, as well as providing the necessary support.

There is a strong link between poverty and imprisonment as economic instability is the biggest consequence of imprisonment on a prisoner's family. The majority of families face financial strain when the earner of the family is in prison. Prisoners who did not provide a financial income for the family are often a financial burden of additional expenses at all stages of the imprisonment, from lawyer fees to sending money to prison to top-up the cost the government insufficiently provide to them. They need more money for prison visits, transport and other expenses. They experience high levels of anxiety about money, especially for stay-at-home women who previously held little responsibility over the family's financial situation.

Families of prisoners face increasing socio-economic and emotional difficulties directly and indirectly related to the imprisonment of their family members. The families are part of a heavily stigmatized and marginalized community with strong vulnerabilities towards isolation and disempowerment. The majority of the families of prisoners fall along the lines of familial stain, kin contamination, or family blaming. They face social injustice and the attack on their human rights. The families need legal and technical advice and information to navigate the justice system. A financial strain, or low economic situation, can rapidly transform into a social vulnerability and have devastating consequences for the safety and stability of a family. This helplessness is heightened as the remaining partner is forced to compensate for the lack of a second income.

They don't receive the same attention as other families with similar socio-economic challenges, as homeless people or unemployed individuals. Any attempt to provide support and raise funds for families of prisoners, as opposed to victims and families of victims, are seen by the media and the public as 'soft on crime and pro-criminal'. People have a belief that unlike the others, they are 'responsible for their own fate', or are themselves criminals, rather than, as the victims they really are. If the offence has taken place within the family or harmed the community, the families are often rejected and further shamed. This is also the case where the offence was of a scandalous nature, in which case friends and relatives are more likely to withdrawal their support and end their relationship.

Imprisonment influences family lives with marginalization and stigmatization. No governmental or non-governmental support system is there to support them in their hard days. Less, almost no people are there to understand their distress and support them in a shame and blame culture. If the family maintains its family ties with the incarcerated member or continue the relationship with an offender after sentencing, the shame and blame from society can be intensified. However, severing the relationship does not lessen the stigma, and in some cases

the families are then also blamed for 'abandoning their family member'.

The stigma and hardship are even gendered if the family member is a care-taking mother of her small children. They suffer as easy targets for society to blame as 'poor parenting' and 'bad mothering'. As either partners or mothers, women are often made responsible for the criminal behaviors of men.

They are being punished for crimes they did not commit and are often themselves victims of the crimes committed by their family. A number of supports like, financial safety-net, information and training must be provided to such families to help navigate the criminal justice system and reduce stigma.

Sudurpaschim Province has poor development infrastructures, less employment opportunities and high social discrimination. The gap between poor and few well-off people is very wide. Cast and gender discrimination is pervasive. Women are even paid low wages than man. Sons are sent to schools not daughter, even if sent, they are sent to government schools whereas their brothers are sent to private schools. In this situation, one can imagine the condition of women facing stigma and financial hardship.

To address the situation, FAYA Nepal is implementing an initiative for better life and livelihood to the prisoner's families through UNDP Nepal's Leave No One Behind (LNOB) initiative.

#### **Objectives:**

The objective of the initiative is to provide financial assistance and education to the families of prisoners to help them overcome the economic and social barriers that prevent their full participation in society. The project aims to improve the financial literacy of families, provide them with the necessary tools to manage their finances, and empower them to access economic opportunities and social services that can lead to a better quality of life. The ultimate goal is to break the cycle of poverty, stigma and exclusion that often affects families of prisoners and promote their social inclusion and well-being.

#### **Highlights of Activities**

Descriptions of the activities are as below, and they are described on an output wise basis.

**Output 1: The local government is more accountable to the condition of the families.** 

Activity 1.1: Inception and learning sharing with local government and others stakeholders

#### Activity 1.1.1 Inception

Two inception meetings were held one in Kailari Rural Municipality (on November 5, 2023) and other in Gauriganga Municipality (on November 6, 2023). In the meetings the activity, outputs and objectives were shared with local stakeholders and their views and suggestions were collected. Mr. Devidatta Kandal, the Mayor of Gauriganga Municipality realized the importance of the unique activity and committed to support in implementation. He also suggested verifying the beneficiaries so that the neediest persons are supported. Ms. Bhagabati Kumari Chaudhary, the Deputy Mayor also welcomed the unique program and also committed to work on the issue

through Municipal Judicial Committee. (The list of participants is in Annex 1.)

FAYA team has visited municipality officials and the community leaders to discuss the importance of the intervention. The officials, especially the Word Chairs, are engaged in

identifying the beneficiaries and verifying them.

Activity 1.1.2 Learning sharing with local government and other stakeholders

At the end of the project, a learning sharing workshop was organized with local government and other stakeholders (on 14 January 2024). In the workshop, the accomplished activities and outputs of the project were shared. Ward Chair of Chure 4 Mr. Dammar Bahadur Singh, Gauriganga 1 Mr. Dabbal Bahadur Diyakoti, Godawari 5 Mr. Suddhiram Chaudhary, and Kailari 3 Mr. Santa Bahadur Chaudhary expressed their satisfaction toward the unique program. They thanked FAYA and UNDP for sensitizing them for the ignored area like such women who are being punished for the crime they never committed. In the workshop, Mayor of Gauriganga, Mr. Devidatta Kandel, and Mayor of Chure, Mr. Chakra Bahadur Bogati and Mayor of Kailari, Mr. Rajsamajh Chaudhary thanked for the program, the continuous coordination of FAYA and the achievement obtained through the project. They also committed to include such type of excluded women in the program and budget of Municipalities. They suggested the beneficiaries to come to the municipality or ward office to share their problems and seek support without any hesitations. This workshop was organized together with Activity 2.3 and 2.5 and utilized for lobby and advocacy too. (The list of participants is in Annex 2.) This workshop is also utilized to handover the initiative to local government to won. A handover certificate was handed over to Municipalities during the workshop. Handover-takeover certificates are attached in Annex 3.

# Output 2: Increased income, awareness of entrepreneurship, access to financial institutions (e.g., banks) & local governments of Prisoner's families

#### Activity 2.1: Household visit, rapport building and need identification

Total 9 families of the prisoners in Chure, 19 in Godawari, 20 in Gauriganga and 11 in Kailari were identified and visited individually to verify. (The list of families is in Annex 4.) Among them, 3 families in Chure, 7 in Godawari, 16 in Gauriganga and 4 Kailari are verified and ready to be engaged in the program.

The needs assessment and feasibility appraisal of 7 families in Godawari, 3 in Chure, 16 in Gauriganga and 4 in Kailari are carried out and the practical business plan are also developed. The sample of Need Assessment and business-plan are in Annex 5. Initially, it was planned for Chure and Godawari only. But when visited the families and verified, the targeted number could

not be reached. Then the FAYA team explored in the adjoining municipalities, Gauriganga and Kailari.

#### Activity 2.2: Financial literacy and entrepreneurship development coaching

Financial literacy sessions were held in the home-yard of all 30 families, especially the spouse of the prisoner so that they can carry out financial activities. Mr. Bhawani Prasad Joshi (a hired facilitator) conducted financial literacy coaching in monthly basis and continued for 3 months. (The list of coaching session and the beneficiary household is in Annex 6.)

#### Activity 2.3: Linking community with financial institute (e.g. banks) and local government

During the household visits and the financial literacy sessions, the beneficiaries and their family members were encouraged to visit banks and local government with their proposals. FAYA representatives had escorted to the visitors to the banks and municipalities so that the families of the prisoners can ask for some support, however, none of the banks responded affirmatively despite hearing their stories emotionally. According to some bank staffs, who responded with the condition of anonymity, that the banks are reluctant to provide loan to the person sentenced to jail, not even to the family members. FAYA attempted to convene a joint meeting involving 12 banks, namely Mahalaxmi Bikash Bank, Laxmi Sunrise Bank, Everest Bank, Machhapuchre Bank, Agriculture Development Bank, NIC ASIA Bank, Sangrila Development Bank, Garima Bikash Bank, Rastriya Banijya Bank, Prabhu Bank, Siddhartha Bank, and Lumbini

Bikash Bank, where the project beneficiaries held accounts, in order to ensure their voices were heard. Unfortunately, none of the bank representatives were present at the event.

Some of the beneficiaries had visited to their respective Wards and municipalities to seek support for their newly established business. 13 of the application among 18 presented were committed by the wards and/or municipalities on the basis of submitted business plans and the approved programs of municipalities/wards. The draft application is in Annex 7.

#### Activity 2.4: Income generation support

Under the activity 2.1, FAYA has conducted the needs assessment and feasibility appraisal of 7 families in Godawari, 3 in Chure, 16 in Gauriganga and 4 in Kailari are carried out and the practical business plan were also developed. Based on the developed business plan each beneficiary has received the cash for income generation activities. The cash is transferred through the beneficiaries' bank account and their business is being monitored regularly. Each beneficiaries were supported Nrp. 20000.00 as the first installment and additional Npr. 20000.00 is topped up after monitoring their performance. (Bank vouchers and monitoring report are attached separately.) Out of total 30, 7 are doing goat farming, 2 are doing piggery, 1 poultry farming, 2 tailoring, 7 retail shop, 8 vegetable farming and 2 mobile vegetable shops are being implemented by beneficiaries. One beneficiary has bought buffalo adding her own saving and started selling milk. (Case study of different beneficiaries is attached separately.) #### Activity 2.5: Market linkage

FAYA has successfully facilitated market linkages for the families of prisoners engaged in income generation activities through an interaction workshop with cooperatives, private businesses, and civil society organizations to create opportunities for collaboration and economic integration, benefiting both the families and the market actors. The families can now access markets for their products and services including products on credit, taking loan and/or grants, while the market actors can benefit from increased access to local products, positive public relations, and visibility. This activity was organized together with activity 1.1 (the learning sharing workshop). The list of participants is attached in Annex 2.

### **Major Results and Achievements**

#### Result & Achievement 1

#### Result:

The inception and learning sharing workshops successfully engaged local government representatives, fostering a collaborative understanding of the project's objectives and activities. In the inception meetings there were 14 representatives from local governments and 19 other stakeholders presented. Likewise, in learning sharing workshop, there were 19 representatives from local governments and 5 other stakeholders and 27 beneficiaries presented. Such stakeholder-involvement resulted in valuable insights and suggestions for future reference, establishing a foundation for informed project implementation and output as-well. The community's increased awareness and understanding of the project were achieved through strategically placed visibility boards, effectively communicating the initiative's purpose and milestones.

#### Achievement:

The successful execution of Activity 1.1 strengthened partnerships with the local government, making them more accountable for the well-being of families of prisoners. The documentation of stakeholder views ensures an adaptive approach, aligning the project with local needs and

challenges. Activity 1.2 significantly increased community awareness, transparently communicating project progress through visibility boards.

#### Result & Achievement 2

Results of Activities under Output 2:

Activity 2.1, involving household visits and need identification, led to the creation of 30 personalized business plans after discussions on market demand, resource availability, skill required, initial investment and past experience. The findings of the Need Assessment and sample business plans provide a comprehensive understanding of the families' needs and potential income-generating activities. Concurrently, Activity 2.2 aimed at financial literacy and entrepreneurship development coaching, ensuring that each family, particularly the spouses of prisoners, receives personalized coaching in their homes. This coaching, conducted monthly over three months, equips them with the knowledge and skills needed to manage their finances effectively and engage in entrepreneurial activities. Activity 2.3, aimed at linking the community with financial institutions and local government, encountered challenges as banks showed reluctance to provide loans to the family members of prisoners. 13 out of 18 proposals presented to wards and municipalities for support were committed. Under Activity 2.4, the income generation support based on business plans developed in Activity 2.1 has yielded tangible results. Specifically, 7 families in Godawari, 3 in Chure, 16 in Gauriganga, and 4 in Kailari received both the first and second installments of cash for income generation activities. The beneficiaries implemented diverse businesses according to their business plans, including 7 engaged in goat farming, 2 in pig farming, 1 in poultry farming, 2 in sewing, 7 operating retail shops, 8 involved in vegetable farming, 2 managing mobile vegetable shops and 1 is selling buffalo milk.

The financial support, totaling NPR 20,000.00 as the first installment and an additional NPR 20,000.00 after performance monitoring, was transferred through their bank accounts, ensuring transparency and accountability. And, the Activity 2.5, focusing on market linkage, involved an interaction workshop with cooperatives, private businesses, and civil society organizations. This collaborative effort, organized concurrently with Activity 1.1, the learning sharing workshop, aimed to facilitate families in building connections with the market. The interaction workshop lays the groundwork for potential market linkages; fostering economic opportunities for the families of prisoners as the private business persons (especially the producers) encouraged them with their testimony and committed to provide subsidies in buying and selling their products. The representatives from Cooperatives provided information about how to join the cooperatives and be benefited.

Achievements of Activities under Output 2:

In Activity 2.1, the formulation of 30 business plans signifies a tangible step towards economic empowerment for the families of prisoners. These plans, developed collaboratively, provide a roadmap

for income-generating activities tailored to the local context. Activity 2.2 has successfully initiated financial literacy and entrepreneurship coaching, empowering spouses with the necessary skills to undertake financial activities. The commitment from wards and municipalities on 13 out of 18 proposals presented to signals a promising achievement in garnering local government support for the families' businesses. Meanwhile, Activity 2.4, focused on income generation support, ensures that families, particularly women, receive financial assistance as a conditional grant (restricted to spent only to implement the developed business plan) to kick start their businesses. This support, transferred through bank transactions, emphasizes the sustainability of the initiative by revolving the support fund through the sale of products. In Activity 2.5, the facilitation of market linkages through an interaction workshop sets the stage for potential collaborations between families and external entities. The concurrent organization of this activity with the learning sharing workshop indicates a comprehensive approach to empower families economically and socially. While challenges persist, the commitment from local governments and the initiation of market linkages mark positive steps toward the increased income and awareness of entrepreneurship for the families of prisoners.

Overall, these activities under Output 2 mark substantial achievements in increasing income, promoting entrepreneurship, and providing tangible support for the families of prisoners in Chure, Godawari, Gauriganga and Kailari.

### **Challenges and Learning:**

#### Challenge:

The basic information about the prisoners was taken informally from Prisoner Administration Dhangadhi, Kailali as they denied providing formal information. FAYA appealed with the Chief District Officer, but he also denied even more strongly. According to him, this information is confidential and cannot be provided. This rejection and reluctance of banks to be engaged with the families of prisoners' is a part of the discrimination and stigma towards them. The stigma, discrimination and deprivation towards them because their family member is in jail is elaborated in the Background section of this report and the case stories attached. The informal information obtained from the Prisoner Administration was not verified fully in the community because some of them were yet to be sentenced and some were going to be released after a few days. Similarly, some people were not married. Some of the prisoners' wives had already left the house. Some did not like to participate in this program. They were angry with their imprisoned husbands. Then FAYA approached to the municipalities, but they even have no record of such information. FAYA continued exploring the way and visited community by community and meet Ward Chairs, community leaders and the female health volunteers and finally obtained and

verified 30 beneficiaries.

Another notable challenge faced by the project is due to the banks' reluctance to provide financial support to individuals associated with imprisonment. The efforts to convene a workshop were also failed and none of the bank representative (among invited 12 banks mentioned above) attended. It reveals a systemic resistance. Anonymously disclosed concerns from some bank staff reflected their unwillingness to extend loans to a prisoners family members. This reluctance presented a significant obstacle, impeding the project's objective of securing essential financial resources for the families of prisoners. The banks' resistance underscores the pervasive stigma associated with imprisonment, hindering the project's goal of fostering financial inclusion and support for vulnerable families.

#### Learning:

Local Government Support: Engaging local government proved to be instrumental, with affirmative response from wards and municipalities indicating a positive step toward obtaining support for the families' businesses.

Adaptive Project Implementation: The need for adaptive project implementation became evident through the documentation of stakeholder views and expansion of the municipalities emphasizing the importance of tailoring initiatives to local needs and challenges.

Diversity in Income-Generating Activities: The diversity of income-generating activities chosen by beneficiaries, such as goat farming, pig farming, and retail shops, underscores the importance of tailoring support to the unique economic opportunities within each community.

Transparency through Bank Transactions: The project's decision to transfer support funds through beneficiaries' bank accounts and monitor business performance ensures transparency and accountability in resource utilization. At the same time, it increased the financial literacy in practical manner.

Importance of Learning Sharing Workshops: Learning sharing workshops facilitated knowledge exchange, empowering the community with insights gained during the initiative and fostering a collaborative approach together with local governments too.

Long-Term Sustainability: The formal handover of the initiative to the local government and the establishment of income-generating activities indicate a focus on long-term sustainability beyond the project's duration. The handover and takeover notes are attached in annex 3.

Market Linkages: Initiatives to facilitate market linkages through interaction workshops with cooperatives, private businesses, and civil society organizations pave the way for potential collaborations, enhancing economic opportunities for families of prisoners.

### **Sustainability of the Project:**

Several key strategies were incorporated in the project implementation for the sustainability of the project beyond its duration. They include sensitization of local stakeholders, including local governments, to understand and address the needs of families of prisoners, connecting beneficiaries with local governments, facilitating market linkages for the families' products and services, the project,

financial literacy and entrepreneurship development coaching, startup finance support to their business and regular monitoring of the initiatives.

The connection of the families of prisoners with sensitized local stakeholders, including local governments, can get continuous support from even after the project ends. Linkage with local markets and businesses can ensure sustained income generation for the families. The women empowered with knowledge and skills to manage their finances effectively, can have long-term financial independence and sustainability, augmenting their income-generating activities such as goat farming, pig farming, retail shops, and vegetable farming. It will provide them financial stability and reduce their reliance on external support.

FAYA, as a local NGO and the initiator of the project, will regularly monitor the activities of the beneficiaries and lobbying with local government for their support to them.


